If you are dissatisfied with this disposal, you can do a query for Minister of Health, Labour and Welfare within three months from the next day of the day on which you knew that this disposal was done. (Except for a case in which one year has passed since the day when the disposal was done.)

2 この処分に対する取消訴訟については、国を被告として(訴訟において国を代表する者は法務大臣となる。)、この処分があつたことを知つた日の翌日から起算して六ヶ月以内に提起することができる(処分があつた日から一年を経過した場合を除く。)

You can raise cancellation suit for this disposal against Japan (A person representing Japan in suit is the Minister of Justice.) within six months from the next day of the day on which you knew that this disposal was done. (Except for a case in which one year has passed since the day when the disposal was done.)

3 ただし、この処分があつたことを知つた日の翌日から起算して三ヶ月以内に審査請求をした場合には、処分の取消訴訟は、その審査請求に対する裁決があつたことを知つた日の翌日から起算して六ヶ月以内に提起しなければならない(裁決があつた日から一年を経過した場合を除く。)

But you must raise cancellation suit for disposal within six months from the next day of the day on which you knew that a decision for the query was done, when you did a query within three months from the next day of the day on which you knew that this disposal was done. (Except for a case in which one year has passed since the day when the decision was done.)
